Dear Secretary Zinke:

On April 28, 2017, President Trump signed an executive order directing the Department of the Interior (DOI) to review where offshore drilling should be occurring and to potentially start a new 5-year planning process for offshore leasing. As Members of Congress opposed to new oil and gas leasing off the Atlantic and Pacific coasts, we urge you to continue to adhere to the recently approved 2017-2022 Outer Continental Shelf (OCS) Oil and Gas Leasing Program (Program) and keep the Atlantic and Pacific OCS Regions off-limits to any new oil and gas lease sales.

The 2017-2022 Program was developed carefully and in full accordance of Section 18 of the Outer Continental Shelf Lands Act, starting with a Request for Information published on June 16, 2014, and finishing over two and a half years later with the signing of the Record of Decision on January 17, 2017. During the process, BOEM received over 3.4 million comments and held 13 public meetings across the country. In recognition of the strong opposition of residents, businesses, and elected officials along the East and West Coasts, BOEM did not include any new lease sales in either the Atlantic or Pacific oceans in the final Program.

Opposition to new leasing in the Pacific OCS dates back to the 1969 Santa Barbara blowout, which killed thousands of birds and marine mammals and blackened the beaches of Southern California. While the Atlantic seaboard has been spared the direct impact of an offshore oil blowout, 121 municipalities, over 1,200 elected officials, tens of thousands of businesses, and hundreds of thousands of fishermen from up and down the East Coast have expressed opposition to oil and gas leasing or exploration in the Atlantic, in recognition of the critical role that clean beaches and oceans play in the economy of the entire region.¹ According to data from the National Oceanic and Atmospheric Administration, tourism and fishing on the East Coast are responsible for over 1.3 million jobs and support a \$63 billion economy. On the West Coast, tourism and fishing support 536,000 jobs and support a \$26 billion economy.² Importantly, these are sustainable industries, able to support jobs and regional economies indefinitely into the future provided our oceans and coastlines are managed smartly. We do not believe that new oil and gas exploration or production activity in the Atlantic and Pacific OCS is compatible with the sustainable coastal economies on which so many of our constituents and communities depend.
